I expressly consent to the release of information as designated above.

ATTENTION RECIPIENT: If the records released include information of HIV-related diagnosis or test results, or any diagnosis or treatment from a substance abuse treatment program, the following statement applies:

This information has been disclosed to you from confidential records protected from disclosure by State law or Federal Confidentiality Rules. These regulations prohibit you from making any further disclosure of this information without the specific written and informed consent of the individual to whom it pertains or as otherwise permitted by law. A general authorization for the release of medical or other information is NOT sufficient for this purpose.
